Financial Report	
Dave provided some details on the Tax Rate and Levy:	
General fund	\$185,000 or 9 cents/\$100 of assessed valuation
CCIF	28,000 or 1.4 cents per \$100 of assessed valuation
Total	\$213,500 or 10.4 cents per \$100 of assessed valuation.

Mickey moved to accept Resolution 2014-1 Budget, Tax Rate and Levy. Nancy seconded. Motion passed 4-0.

Nancy gave her report on the financial reports and the claims. . She moved to accept the claims register and seconded by Mickey. Motion carried 4-0. Mickey moved the Board has reviewed and accepts the financial reports and Tom seconded. Motion carried. 4-0.

Brent Wagner was given the floor to report on the space needs analysis. Looking at what we can do with what we have. The conference room is the major concern. Restroom is not assessable. Manager's room and financial secretary are out of room. More vehicle storage is needed. The present needs can be taken care of, but not if there is much expansion/growth of the District.

Nancy made a motion to refer this to the Engineering committee. Seconded by Tom. Motion carried 4-0.

General Manager's report.

Water main project on hold until the last 9 manholes are jetted.

JPR has given a quote of \$8500 for their share of the work to get the project of the entire subdivision of Sunny Lane to bid.

Bob suggested for Dave to approach Steve Poulos first and then see if we can get the majority of homes to participate or at least 50%. The cost would be approximately \$10,000 per home. Nothing can be done until we hear from the City. Dave will show the City the engineering report and see what happens. Dave will report back at the next meeting. Dave discussed the current thought process of the City wishing to use our lines to advance north to at least Highway 6. Bob M. provided plans and details to Steve Poulos about our sanitary sewer system.

Lake enhancement at the DNR office. They will give us a little more money to treat Flint with Trichlor and continue with a maintenance treatment on Long. Indiana American has not provided a formal proposal.

Matt's field report.

One new home going up on Island Road. Raised two sewer lids, jetted 7200 feet of sewers, 2 meter change outs, 22 locates, 25 delinquents.
