Meeting was called to order by Chairman Dick Brychell at 5:58 pm.

Tom made a motion to approve the minutes. Seconded by Bob. Motion carried.

Review of Conservancy District Budget

Payment of Per Diems will be in January to avoid two 1099's.

\$812.82 in negatives for the year. Motion to move the money from Travel line items to cover the negatives was made by Tom. The motion was expanded to include any additional costs creating a negative will be paid out of Contractual Services line items. Seconded by Bob. Motion carried.

Review of the Water Utility

Water was positive \$2600 for the month and \$19,173 for the year.

Patton's bill for the skid was about \$2000 lower than expected. It was questioned and Patton held firm on the lower cost.

Bob question the line of credit and the check sent to Patton. Dale explained the differences.

Review of Sewer Utility

Sewer was positive \$4300 for the month and negative \$21,000 for the year.

Culy Construction was paid \$7850 for two manholes.

Megan asked if the "Y" could be helped by VLACD in their soil erosion. Bob M. will check into offering help. Start with a letter to the City engineer's and the executive director of the "Y", Bob Wanek.

Maintenance Report

Matt reported an illegal turn on at 5303 Leisure Lane that resulted in a flooded house. It was roughly calculated at 2000 cubic feet as per a master meter since the home's water meter had been tampered with. Dave asked for the information so he could take it to the prosecutor's office if need be.

Matt gave his report with two water samples taken. 21 locates and a hydrant extension. Gasvoda had received the wrong parts for Ostedt lift.

Bob mentioned a building committee meeting 1/13/2012 7am at the Bow Coffee Shop.

Claim forms were signed. Deb made a motion to approve them. Bob seconded. Motion carried.

Accounts Receivable Report

Laura reported a letter was received from the Murray's requesting relief on the sewer bill for a leak in his sprinkler system. We estimated that this amounted to \$89.32. Bob reminded the Board of how uncooperative this customer was I the past. It was decided that a letter should be sent to him informing him that this would be the last relief we will offer and he needs to replace his line if this continues or install a separate meter. A motion to approve the credit for \$89.32 was made by Deb and seconded by Tom. Motioned carried.

Engineer's Report

Kenn mentioned the manhole lined by Culy Construction is the prettiest manhole in the District.
