Meeting was called to order by Chairman Bob Garmon at 6:00 pm
Suspended agenda to open and read the bids.

Dave received from Jean the 5 bids.

The Financial Committee's report.

The Conservancy District Budget Analysis was reviewed and the Financial Statement was reviewed and Mickey moved to accept them. Rolando seconded it. Motion carried. 7-0.

The Cumulative Improvement fund was reviewed by committee.

The Claims were reviewed by committee and Mickey moved to approve them. Rolando seconded it. Motion carried 7-0.

The agenda was suspended again and the floor given to the audience. James Holland spoke first. They were all residents of Flamingo Road. Since the water main was installed there has been nothing but trouble with storm water. Road was improperly graded and too much stone added. There are ruts 6" deep. Just wants the road graded down to the hard pack.

Mr. Holland had a bob cat scraped the road. Matt reported to Bob M. that the house was in very serious condition before Mr. Holland bought the house. Mr. Holland and his

neighbors were unaware of any previous problems. Bob M. reported that 5 homeowners along Flamingo wanted additional gravel when the project was done. Bob gaveled the audience and members to keep it to one person at a time. Bob G. agreed to come out at 4:00 pm the next day and will allow one other member to attend. There was another complaint of the storage area not being cleaned up. A piece of pipe remained. Mr. Kelley was brought up and his yard was full of stone. Bob M. reported that he and the crew personally picked up the rocks and brought in dirt for around the hydrant that was low.

2 days at the Expo Center with rain barrels. Nancy stayed one day and handed out milkweeds. This was for Earth Day.

Two loads of brush taken to the Porter County recycling center to be turned in to mulch.

Bob G. asked about how they were holding up. The first one did not hold well but the rest have been very good. Don mentioned that it could be funded for more spraying.

Bob M. suggested that we raise the manholes that are too low and aligning those off center.

A discussion ensued about which ones, where they are at and any additional work might be needed.

Mickey suggested we stay within the budget. Next year maybe more funds can be appropriated.

2 samples good.

25 delinquents. 36 locates, 3 seasonal turn offs, zero meter replacements.

No customer appreciation day this year due to the construction plans.

Request from the City's utility agreement was reviewed. Tom will run point with Mr. Poulos.

Two places for the temporary office. Old Church at \$600 month. Curves wants \$1100 per month. Curves has more room and more secure. Both will give short term. His opinion Curves would be better. Christian mention a newer building should be better on utilities. Dave wants to look closer at the lease. Tom will contact realtor and explain our interest. Bob moved to accept the Curves office with Dave's approval. Nancy seconded it. May 1 to Oct. 1 and then month to month. Motion carried 7-0.

Finance Committee Mickey

At the meeting several things discussed. West Long Lake letter ready. Annexation explained, annexation petition agreement, and Board of Health letter to go out with it. Bob hopes to get the 13. If the owners at least agree to annexation then when they hook up later then they will not have to pay the annexation later. Letter asks for a deposit. Bill Pauley called and wants in on the project. Half of the owners must agree for the project to continue. Rolando made the motion to send the letter. Bob seconded it. Motion carried.

Discussion on sending all the information together. It was agreed to everything in one packet.

Next, Mickey brought up trying to get a better handle on the budget. Dave will now give us a quarterly bill. Committees need to meet on the same day if possible.

Tom still believes if you are not on a committee you should not get paid for attending.

Tom moved to rescind the former motion where all attendees get paid for committee meetings. Don seconded it. Bob talked about how it was in the past with only one meeting per month. He explained that the committee meetings are vital and all should attend and be paid. Christian talked about that being paid makes it an obligation to attend. Rolando thinks that the Chairman should be paid for all meetings or paid at a higher rate. Motion carried 4-3. Nay - Christian, Nancy and Bob.
