## Sewage Tracking Adjustment

The Valparaiso Lakes Area Conservancy District Sewage Works pays for the sewage treatment, at wholesale, from the Valparaiso Water Reclamation Department, Valparaiso, Indiana. To provide for coverage of costs, the Valparaiso Lakes Area Conservancy District Sewage Works adopts a Sewage Tracking adjustment factor to automatically adjust sewage charges occasioned by changes made by the Valparaiso Water Reclamation Department. The adjustment shall be a pass through of the increased charge assessed by the Valparaiso Water Reclamation Department.

Effective July 1, 2025:	\$1.87 per 100 cu. ft
Effective July 1, 2026:	\$2.45 per 100 cu. ft

Effective July 1, 2028:	\$3.76 per 100 cu. ft
